



## **Tesco Clubcard Partnership Terms and Conditions**

- Minimum Royal Caribbean cruise fare £510 per guest excluding taxes and charges (£510pp cruise fare is after any applicable & combinable promotions have been applied for each guest within the stateroom).
- Maximum Clubcard voucher redemption £510 per guest.
