

Singapore HRTS Protocol

(Updated on Oct 24th)

Entry into Singapore: (Please refer the Singapore government's requirements for inbound tourists . The following information is for reference only)

- All guests entering Singapore do not need to be vaccinated or quarantined. They are only required to provide a negative PCR test within 2 days prior to entry
- ARTs will no longer be required arrival in Singapore.
- Passports should meet the minimum requirement of at least 6 months validity after the cruise's return date.

What to Bring to Pier:

1. Non-vaccinated guest who 5-11 years old need a negative test (ART or PCR) result for COVID (Details as below)
2. COVID-19 Vaccination Record Card (Details as below)
3. Passport (Valid for at least six months after your sailing's return date)
4. Singapore Arrival Card (All international guests need to complete the Singapore Arrival Card at least 1 day prior to the end of the sailing)
5. Online Check in Document (Print Out)

COVID-19 Vaccination Validation:

1. All guests ages 12 and above must complete the second shot of vaccination 14 days by their sail date. guest below 12 years old can sail non-vaccinated
- Singapore passport: must complete booster shots if meet the time requirement, as shown in TraceTogether APP if the vaccination status is "vaccinated" and within the validity period
 - Foreign passport holders with Singapore PR/ work visa/student visa and other long-term stay in Singapore: must complete booster shots if meet the time requirement, as shown in TraceTogether APP if the vaccination status is "vaccinated" and within the validity period
 - Foreign passport does not stay in Singapore for a long period of time, enter Singapore on a tourist visa: Complete 2 shots of vaccination

1. Malaysia now allows all travelers to enter Malaysia regardless of their Covid-19 vaccination status.
2. Everyone 18 years of age and older must be fully vaccinated for COVID-19 with an approved vaccine at least 14 days before travelling to Thailand.

Pre-Arrival Covid Test Validation

1. Unvaccinated guests ages 5 - 11 must present a negative COVID-19 test result taken no earlier than 3 days prior to sailing. Fully vaccinated guests ages 12 and above do not need to test for these sailings.

-Accepted tests are FDA-approved PCR or antigen tests, including unsupervised self-tests. Proof of a negative test can be the printed or digital results, a clear photo of your self-test result, or your actual self-test in hand.

-For sailing on 31 Jul 2023, All guests ages 5 and older must present a negative COVID-19 test result taken no earlier than 3 days prior to sailing.

***Guests will be denied if:**

1. They cannot produce a negative test
 2. If they have not received their test results
 3. They produce a presumptive positive test
2. Back-to-Back (B2B) Sailing Protocols
 - MOH-STB has approved for the test of ART to be conducted by the shipboard medical.
 - The same testing will allow them to reboard the ship if the testing is done 24 hours before the ship departure.
 - Guests is able to reach out to Guest service team when they are onboard to arrange for their ART test. Guest service team also drop a note to B2B guests informing them on their ART testing requirements 1-2 days prior to disembarkation.
 - The shipboard medical will provide a manual memo for the guests to show when requested.
 - This ART testing services performed by shipboard medical team for B2B guests is free of charge.

Notice for Port of Call – Malaysia

1. Malaysia now allows all travelers to enter Malaysia regardless of their Covid-19 vaccination status.

- Travelers will need to follow the Vaccination Guide to enter Premises in Malaysia. They may be stopped by Premises if the guest doesn't meet the Vaccination Guide. Guests who only have 2 doses of Sinovac or Sinopharm, as well as guests aged 60 and older who have not yet received their booster, are considered to be partially vaccinated by the Malaysian Government. To be considered fully vaccinated is as below.

² All recipients of Sinovac and Sinopharm vaccines aged 18 years and above as well as recipients of all primary dose vaccine types aged 60 years and above will lose their Fully Vaccinated Status in their MySejahtera application if they have not received their booster dose starting 1 April 2022. However, primary dose vaccine history will remain available in the MySejahtera application³.

³ For the group of Individual described above ⁽²⁾, they are still allowed to perform activities that are permitted for Individual who have received complete primary dose vaccination.

⁴ Booster dose requirements for *Umrah* and *Hajj* pilgrims have been set by the Malaysian Government due to the high risk of infection at public gatherings in the Holy Land. Pilgrims under the age of 18 are not subjected to this requirement if performing *umrah* with family members who are fully vaccinated and received booster dose.

- Guests are no longer required to submit the pre-departure form to obtain blue traveler's card. Also, Guests are no longer required to download/install the MySejahtera app. Travelers can download and activate the app. This may be requested by Premises, also, anyone with "High Risk" on the MySejahtera App will be denied entry to public spaces/Premises.
- Visa
 - Hongkong guest : no visa requirement
 - China mainland guest: no visa requirement

Notice for Port of Call – Thailand

- Everyone 18 years of age and older must be fully vaccinated for COVID-19 with an approved vaccine at least 14 days before travelling to Thailand.

2. Guests 5-17 years of age travelling to Thailand unaccompanied must get vaccinated with at least 1 dose of an approved vaccine at least 14 days before travelling to Thailand. Those travelling with parents are exempt from this requirement. If the person is traveling with Guardian, they must have at least 1 dose of an approved vaccine.
3. Visa:

Hongkong guest-no visa requirement

China mainland guest- VISA or VISA on arrival (VOA) (THB 2600/pax may be subject to change)

*For guests who require a visa to enter Thailand, please bring with you two (2) passport-sized color photos for the Thailand Visa-On-Arrival Application (VOA)
4. All guests need to bring a copy of their passport photo or information page in order to debark and explore in these ports. (A soft copy or photo of your passport information page will also be accepted.)

Additional Information:

1. Online check-in will begin 30 days prior to your sailing. Make sure to download our app for faster check-in, real-time itineraries, dining, shore excursions, and more.
2. Masks are no longer required to be worn onboard except when at the medical center.
3. No safe distancing required in all settings.
4. Food & Beverage establishments: Dine-in is allowed with no restrictions on group size.

皇家加勒比海外航次复航参考政策-新加坡母港

(更新与 10 月 24 日)

入境新加坡：请参考新加坡政府对入境游客的最新要求。以下信息仅做参考

- 所有入境新加坡的人士均无需疫苗，无需隔离，只需要提供入境前 2 天内的核酸检测阴性报告
- 入境后的自我抗原检测不再要求。
- 护照有效期需要在航次结束后依旧大于 6 个月。

所需材料

1. 5-11 岁未打过完整疫苗的客人抗原检测或核酸检测阴性报告（详情求见下文）
2. 新冠疫苗接种记录（详情见下文）
3. 护照，有效期需要在航次结束后依旧大于 6 个月
4. 新加坡电子入境卡（所有国际乘客需要最晚在航程结束前一天完成新加坡电子入境卡的填写）
5. 在线值船打印文档

新冠疫苗接种要求

1. 所有 12 岁及以上乘客必须在开航前 14 天完成第二针疫苗接种，加强针没有时间要求，12 岁以下乘客可以选择不接种疫苗。
- 新加坡护照乘客 – 若符合加强针接种时间要求，则必须接种，具体可以查看 TraceTogether APP 中疫苗接种状态是“已接种”并在有效期内
- 外国护照持新加坡 PR/工作签/学生签等长期停留新加坡的乘客-若符合加强针接种时间要求，则必须接种，具体可以查看 TraceTogether APP 中疫苗接种状态是“已接种”并在有效期内

- 外国护照不长期停留新加坡，以旅游签证进入新加坡-完成 2 针疫苗接种即可
- 2. 所有乘客（不论疫苗接种情况）均可在马来西亚下船。
- 3. 所有 18 岁及以上的乘客需要在抵达泰国前 14 天完成疫苗接种，可在泰国下船。

行前检测要求

1. 5-11 岁未接种疫苗乘客需要在开航前 3 天内完成新冠检测；12 岁及以上，完成完整疫苗接种的乘客不需要进行行前检测。

-可以接受 FDA 认可的核酸或抗原检测（包括无监督的自我检测），打印或电子的阴性报告都可接受，或者自我检测后的检测结果照片，也可以直接携带检测后的试剂盒

-2023 年 7 月 31 号航次：所有 5 岁及以上客人需要在开航前 3 天内完成新冠检测

以下情况客人将被拒绝登船：

1. 无法提供抗原检测阴性结果
 2. 客人还没有收到检测结果
 3. 检测为阳性
2. 背靠背航次要求
 - MOH-STB 已经认可由船上医疗团队安排的 ART 检测
 - 客人可以凭借下一个航次开船前 24 小时内的 ART 检测报告登船
 - 客人可以在宾客服务中心咨询 ART 检测的相关事宜，船方也会在第一个航次结束前 1-2 天，通知背靠背航次乘客相关检测事宜。
 - 船方医疗团队可以提供手写证明供客人登船使用
 - 船方提供给背靠背航次乘客的 ART 检测不收取费用

停靠港注意事项-马来西亚

1. 所有乘客（不论疫苗接种情况）均可在马来西亚下船。

2. 乘客如需进入公共场合，仍需遵守马来西亚政府的疫苗接种要求，如果乘客未能完成完全接种，可能会被拒绝进入。只接种了 2 针 Sinovac 或 Sinopharm 的客人，以及超过 60 岁无法接种加强针的客人，将被马来西亚政府认定为仅完成了部分疫苗接种。马来西亚政府对完整疫苗接种的判断见下图

3. 乘客不再需要申请 blue card，也不再需要下载 MySejahtera app。但乘客依旧可以选择下载并激活 MySejahtera app，部分公共场合可能需要出示此 app，如果 MySejahtera app 中显示“高风险”则无法进入公共场合。

中国大陆乘客-无需办理签证

停靠港注意事项-泰国

1. 所有 18 岁及以上的乘客需要在抵达泰国前 14 天完成疫苗接种，可在泰国下船。

2. 5-17 岁乘客如果不与父母同行，最少需要完成 1 针疫苗接种，如果与父母同行则无此要求。

3. 签证信息

香港乘客-无需办理签证

中国大陆乘客-需要办理签证或者落地签(THB 2600/人 可能随时调整)

*对于需要签证入境泰国的客人，请携带 2 张护照上大小的彩色照片，用于泰国落地签申请

4. 所有客人需携带护照照片或信息页的复印件，以便在停靠港使用（护照信息页复印件及照片都可用）

补充信息

1. 在线值船将在开航前 30 开放。请下载 Royal Caribbean App。
2. 除在医疗中心外，旅客不再被要求佩戴口罩
3. 所有区域没有强制的安全社交距离。
4. 用餐机制：所有餐厅均可堂食，且没有人数限制。
