

ROYAL CARIBBEAN SINGAPORE SWEEPSTAKES
OFFICIAL RULES

Sponsor’s computer is the official timekeeping device for this Sweepstakes.

BY PARTICIPATING IN THIS SWEEPSTAKES, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES, WHICH CONSTITUTE A LEGALLY BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE PARTICIPATING. - 1. SPONSOR:** The Sponsor for this Sweepstakes is Royal Caribbean Cruises (Asia) Pte Ltd, a Singapore registered company (company number 200703693G) with principal place of business at 3 Anson Road, #13-02 Springleaf Tower, Singapore 079909 (“Sponsor”).

Upon completion of an eligible and qualifying New Booking, and completing and submitting the entry form with all required information, you will receive one (1) entry into the Sweepstakes. By submitting an entry in this Sweepstakes, you consent to the collection, use and disclosure of your personal data by the Sponsor for purposes reasonably related to the administration of the Sweepstakes, including the Sponsor contacting you via email, phone or social media, including on Facebook, Instagram or X in connection with your participation, potential winner selection, and prize fulfilment. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant or participant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider, Internet service provider or other organization (which may include an employer) responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. Entries specifying an invalid, non-working or inactive email address will be disqualified and ineligible to win.

4. **SELECTION OF WINNER:** On or about October 15, 2025, Sponsor will select the name of the potential winner of the prize in a random drawing from among all eligible entries received. The odds of winning are based on the number of eligible entries received. The potential winner will be notified via the email address and/or telephone number provided at the time of entry.

Except where legally prohibited, each potential prize winner must sign and return, within fourteen (14) days of being notified, a Declaration of Eligibility, Liability & Publicity Release (the "Declaration"), and agree to all requirements associated with taking delivery of the prize vehicle, as described herein in order to claim their prize. PRIZE RESTRICTIONS: Any and all applicable taxes (including goods and services tax) and all fees and expenses related to acceptance, registration and use of prize not specifically stated herein are the sole responsibility of the winner. Prize cannot be substituted, assigned, transferred or redeemed for cash, and winner is not entitled to trade-in or sell the Prize for the purchase of another vehicle offered by Vantage Automotive Limited or any of Vantage Automotive Limited's affiliates or related corporations. However, Sponsor reserves the right to make prize substitutions of equal or greater value at their sole discretion. Sponsor is not responsible for and will not replace any lost or stolen prizes. Prize cannot be used in conjunction with any other promotion or offer. Only the number of prizes stated in these Official Rules is available to be won in the Sweepstakes. If, by reason of a print, technical, or other error, more prizes are claimed than the number set forth in these Official Rules, prize winner(s) will be selected in accordance with the winner selection method described above from among all eligible claimants making purportedly valid claims to award the advertised number of prizes available. Sponsor is not responsible for any delay or cancellation of the prize delivery due to unforeseen circumstances or factors beyond Sponsor's reasonable control. If the fulfilling merchant cancels the order for reasons outside of Sponsor's reasonable control, the prize may not be delivered and no additional compensation will be provided unless required by law.

- 9. DISPUTES.** This Sweepstakes is governed by the laws of Singapore. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the participant and Sponsor in connection with the Sweepstakes, shall be governed by and construed in accordance with the laws of Singapore, without regard to any conflict of law rules that would result in the application of the laws of any other jurisdiction.

Except where prohibited by law, each participant agrees that:

- a. Any and all disputes, claims, or causes of action arising out of or in connection with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration administered by the Singapore International Arbitration Centre ("SIAC") in accordance with the Arbitration Rules of the SIAC in force at the time. The seat of arbitration shall be Singapore. The tribunal shall consist of one arbitrator, and the language of the arbitration shall be English.
