

**“HOMETOWN LEGENDS GIVEAWAY” WITH ROYAL CARIBBEAN
OFFICIAL RULES**

Upon completing these steps, you will be automatically entered with one (1) entry into the Sweepstakes. If you do not have an Instagram account, you can

create one for free at www.instagram.com. When you take these actions, you automatically will be entered with one (1) entry into the Sweepstakes.
