Deposit Requirements

The deposit to secure a BL reservation is \$200 USD per stateroom. Deposits must be paid during the Offer Period. All deposits are non-refundable once paid.

Additional deposit may be required at the time of converting a BL reservation to a ship and sail date.

- For Balcony and below categories for single and double occupancies, the initial \$200 deposit will satisfy the deposit requirements for the stateroom.
- For Balcony and below categories with higher occupancies, an additional \$100 per person deposit is required for each guest beyond double occupancy.

Offer Redemption

To redeem a BL reservation, you must convert your Book Later to a confirmed booking by selecting a ship and sail date no later than one (1) year after the booking date. The confirmed booking will automatically be designated as having a non-refundable fare. The original BL reservation number must be provided at the time of conversion.

You will be eligible to receive the NextCruise Savings Offer if you select a ship and sail date within two (2) months of the booking creation date. If you select a ship and sail date after two (2) months of the booking creation date, you will not be eligible for the NextCruise savings offer, but your deposit will still be valid until the expiration date.

The BL Savings Offer will be applied to bookings automatically within 72 hours of booking conversion to eligible reservations.

Expiration

Groups

NextCruise Bookings may be transferred into an existing non-contracted group, assuming required criteria are met. BN, BL and Bonus offers are combinable with Group Standard Rates, and GAP Point Offers. Group Naming Bonus offers are not combinable with NextCruise offers.

Booking Channel

Book Now: After initial booking creation onboard, all standard transfer policies apply to NextCruise Book Now reservations.

Book Later: Prior to a ship and sail date selection, a Book Later reservation may be moved from Direct to a Travel Advisor at any time. There is no time restriction if it has not yet been converted to a specific ship and sail date.

Once converted, standard transfer policies apply with the conversion date to a ship and sail date serving as "creation date" for the purpose of these policies. Guests will have 30 days from the date of conversion to a ship and sail date to transfer.
