

NEXTCRUISE BOOKING TERMS AND CONDITIONS

****Effective as of December 15, 2025***

Royal Caribbean's NextCruise Program (the "**Program**") provides guests sailing on or participating in authorized day visit on a Royal Caribbean, Celebrity Cruises, or Silversea ship (the "**Offer Period**") an exclusive offer ("**NextCruise Offer**") when they make a booking for a future Royal Caribbean cruise three (3) nights or longer ("**Offer Cruise**") with Book Now ("**Book Now**") or make a reservation for a future cruise with Book Later ("**Book Later**") and pay the minimum required deposit (the "**Deposit**"). The NextCruise Offer with Book Now is the "**BN NextCruise Offer**". The NextCruise Offer available with Book Later is the "**BL NextCruise Offer**".

The Program is operated by Royal Caribbean Cruises Ltd. ("**Company**") under the terms and conditions as set out below unless expressly stated (the "**Program Rules**").

BY MAKING A PROGRAM BOOKING OR RESERVATION, YOU, THE GUEST ("**guest**", "**you**" or "**your**") AGREES:

- you have read, accept and agree to be bound by these Program Rules and any policies and documents incorporated herein by reference;
- you have read and accept the [Cruise Ticket Contract/Booking Conditions](#), which contain important limitations on the rights of passengers, including provisions relating to limitation of liability, forum selection, governing law, and the use of alternative dispute resolution to resolve certain types of disputes, and any dispute or claim that is related to your cruise and/or purchase thereof; and
- you consent to the collection, use, sharing, receiving and disclosure of your personal data in accordance with the [Company's Privacy Policy](#).

1. **BOOK NOW.** Book Now provides guests who book an Offer Cruise on a **specific Royal Caribbean ship and sail date** (the "**BN Offer Cruise**") during the Offer Period, their choice of an instant savings or onboard credit ("**OBC**"), valued at up to \$300 USD per stateroom, varying by length of sailing, stateroom category and itinerary. Savings shown in USD will be converted to the booking currency if booking in a currency other than USD.

1.1. **How to Book.** Book Now bookings are available as non-refundable deposit fares and require the full legal name of at least one (1) person and payment of the Deposit at the time of reservation creation. The Deposit for a Book Now booking is \$100 per person for all staterooms, excluding suites. For all Book Now bookings in a suite, a Deposit equivalent to 10% of the cruise fare is required. The Deposit is non-refundable.

1.2. **Further Payments.** Payments on your Book Now booking beyond the deposit shall be due in accordance with the Company's [payment schedule](#) applicable in your country of residence.

1.3. **Cancellations.** Your Deposit and any further payments made towards a Book Now booking are not refundable at any time. At least one (1) person named on the reservation at the time the booking was created must sail or it will be treated as a cancellation.

1.4. **Changes.**

a. **Increased Deposits.** Certain changes to a Book Now booking will increase the Deposit, including but not limited to upgrading to a suite. Any additional Deposit amounts are due at the time of modification. The guest must retain the same booking number assigned at the creation of the Book Now booking to keep any qualifying onboard offers.

b. **Changes Fees.** Any changes made to Book Now bookings, including but not limited to a change to the ship or sail date, two (2) months or more after creation, incur a fee of \$100 USD/CAD/1275 MXN per person per change (the “**Change Fee**”). All payments made towards a Book Now booking will be applied to the balance of the modified booking and the Change Fee(s) will be charged.

2. **BOOK LATER.** Book Later provides guests who make a reservation (“**BL Reservation**”) on an Offer Cruise **but do not select a ship and sail date** (the “**BL Offer Cruise**”) during the Offer Period their choice of a savings or onboard credit (“**OBC**”), valued at up to \$300 USD per stateroom, varying by the length of sailing, stateroom category and itinerary. Guests must select a ship and sail date for their BL Offer Cruise no later than two (2) months after making the BL Reservation and pay the required additional deposit(s) to receive the OBC. For BL Offer Cruises departing from Australia, guests have four (4) months after making the BL Reservation to select the ship and sail date and pay the required additional deposit(s). A BL Reservation does not guarantee stateroom or sailing availability or cruise price.

2.1. **How to Book.** BL Reservations are available as non-refundable deposit fares and require (i) payment of the Deposit upon making your BL Reservation; (ii) the full legal name of at least one (1) person; and (iii) you convert your BL Reservation to a confirmed booking by selecting a ship and sail date for the BL Offer Cruise no later than four (4) months after making your BL Reservation if selecting a ship and sail date for a BL Offer Cruise departing from Australia, or no later than two (2) months after making your BL Reservation for all other departures (“**Selection Period**”). The Deposit is \$200.00 per person and is non-refundable.

a. **Additional Deposit(s).** For BL Reservations in any Balcony and lower stateroom categories with more than double occupancy, an additional non-refundable deposit of \$100 per each additional person will be required to convert the BL Reservation to a confirmed booking. Additional deposit(s) equivalent to 10% of the cruise fare are required for all suite categories. Any additional deposits must be paid in full to convert a BL Reservation to a confirmed booking. The Deposit and any additional deposits will not be refundable at any time.

2.2. **Further Payments.** Once you have converted your BL Reservation to a confirming booking, payments on your booking beyond the required deposits shall be due in accordance with the Company’s payment schedule applicable in your country of residence. Visit your NextCruise Desk onboard and/or the Company’s website in your country of residence for more details and full terms and conditions.

2.3. **Expiration.** If a BL Reservation is not converted to a specific ship and sail date during the Selection Period, the BL Next Cruise Offer will automatically expire. If a ship and sailing date are not selected within one (1) year of creating the BL Reservation, the BL Reservation will be canceled. The Deposit is non-refundable.

2.4. **Cancellations.** If a BL Reservation is cancelled prior to selection of a specific ship and sail date, the Deposit will not be refunded. If a BL Reservation was converted to a specific ship and sail date within the Selection Period and later cancelled prior to the final payment due date,

the cancellation terms applicable to your booking (which may vary from country to country) will apply and any deposits paid will not be refunded. At least one (1) person named on the BL Reservation at the time it was converted to a confirmed booking must sail or it will be treated as a cancellation.

- 2.5. **Changes.** Subject to the restrictions set forth in Section 3 below, a BL Reservation may be transferred to another person prior to the selection of a specific ship and sail date. Upon converting to a confirmed booking, any changes, including but not limited to a change to the ship or sail date will incur a Change Fee. All payments made towards a Book Later booking will be applied to the balance of the modified booking and the Change Fee(s) will be charged.

3. ADDITIONAL TERMS AND CONDITIONS FOR ALL PROGRAM BOOKINGS.

- 3.1. **Travel Partners.** Your Program booking will be attributed to the travel partner associated with the Offer Period sailing, unless you change it at the time of booking by completing an authorization form. After the Offer Period, all [standard transfer policies](#) apply to Book Now bookings. A BL Reservation may be transferred to a Travel Partner any time prior to thirty (30) days after selecting a ship and sail date.
- 3.2. **Additional Offer Terms.** Only one offer (choice of Savings or OBC) shall be awarded for each qualifying Program booking. Single occupancy guests may receive a pro-rated Offer depending on the single supplement fare paid. OBC has no cash value, may be used onboard the Offer Cruise only, is not transferable, not redeemable for cash, and will expire if not used by 10:00 PM on the final night of the Offer Cruise.
- 3.3. **Program Booking Restrictions.** A maximum of three (3) Program bookings of up to three (3) staterooms each, can be made per person, 21 years of age or older, per Offer Period for yourself, your friends or family. Back-to-back consecutive cruises will be treated as one Offer Period when determining the number of Program bookings a person is permitted to make. Program bookings cannot be used for Travel Agent resale. Some Program terms may vary by departure port or booking office/country under which the NextCruise reservation is made. The NextCruise Program is not available on sailings with an arrival and departure port in China.
- 3.4. **Changes Impacting Cruise Fare.** Any changes to a Program booking that include a different ship, sail date or stateroom category, or combining the booking with another offer, may impact the cruise fare. The cruise fare due for any changes to a Program booking will be determined by the prevailing rates on the date of the requested change in the guest's country of residence. Changes to the ship or sail date are prohibited after final payment due date and will be treated as a cancellation. Please check with your local Travel Professional or visit our website, www.royalcaribbean.com for available updated fares.
- 3.5. **Groups.** Program bookings may be transferred into non-contracted groups; however, higher deposits may be required and promotional offers and/or Program benefits may be forfeited. Individual enrollment may be converted and applied to a group booking.
- 3.6. **Combinability.** Certain promotional offers available in your country of residence may be combinable with any special promotional offer you may have received onboard when you made your Program booking. Certain Casino Offers and Instant Rewards Certificates issued during the Offer Period may be combinable with the Offer if redeemed within thirty (30) days of making the Program booking, subject to the [Casino Offer terms](#). If a promotional offer is not combinable,

you may be able to replace a special promotional offer with that general market promotional offer but the cruise fare will be adjusted to reflect a rate then available in your country of residence as of the date of your requested change. Confirmed Program bookings are combinable with most general market offers. Program bookings may not be combined with certain promotions and discounted rates including, but not limited to, Interline, Travel Agent or Travel Agent Friends rates, group naming bonus offers, Last Minute Cruise Deals, weekly sales events, net rates or employee rates. Please note some international policies differ. Program may not be available in your country of residence. Cancellation of your booking may be subject to cancellation charges. See your Future Cruise Vacations Team for details.
